Bob Sours— History Center Docent to Society President



Approximately two and one half years ago I responded to a notice from the Fair Oaks Historical Society that announced they were looking for a new docent at the History Center. What's New at the History Center...

You may not have noticed that we've changed the History Center hours to better accommodate our mid-week visitors. We're now open Tuesday and Thursday, 10 to 2, and Saturday, 10 to 3. We're also available to open the History Center by appointment for visitors. Contact me for prearrangements.

We are continuing to add videos to the Rotary Theater. Latest are oral interviews with Harry and Jane Dewey, and the dedication ceremony for the Founder's Monument, all provided by Larry Fritz, and all available on our big screen. If you missed the Founders Dedication and want to see it, drop by the History Center and let us know.

We currently have four oral history videos, four video shows, two TV video clips, and three repeating slide shows. We'll put a listing of these with descriptions on the website. Just ask at the History Center if you'd like to view any of these.

Old Homes of Fair Oaks

**Thompson House – 7816 Sunset Avenue
(Southeast corner of Sunset and New York Avenues)**




The house on Sunset Avenue & New York is known to historians as the Thompson House. It was built about 1905 by two brothers, General J.F. and Colonel E.M. Thompson, both bankers from Iowa.

There isn't any evidence that either of them ever lived on the property, and one article said they were involved with the Howard & Wilson publishing company and also invested in Florida property.

This house was researched by Steve Abbott in about 1990 in a general effort to document old Fair Oaks homes. We know of no old photo showing the home except the one of Sunset Avenue in which the house is hidden behind the trees. Steve labeled the house “The Thompson House” in his survey, so I suppose he found something in the County property records that indicated Thompson as the first owner of the property.


The list of founding fathers shows an initial investor in Fair Oaks as Gen. J. F. Thompson, Banker, Forest City, Iowa. I suspect he bought several parcels of land in the area in Fair Oaks as an investment.

The developers of Fair Oaks— the Howard & Wilson Publishing Company of Chicago— had four “Sunset Colonies” they were developing— North Carolina, Louisiana, and Los Angeles, and Fair Oaks—and other developers were doing the same thing in other parts of the country.



Thompson's biography says he was investing in land in Florida. The 1910, 1920 and 1930 censuses show Thompson living in Forest City. The brothers are shown in an early photograph of Fair Oaks colonists and investors,

I can find no record of the next two owners, Londonberg (1920) and Dillingham (1930), ever living in Fair Oaks, so the property was probably being handed around as an investment and leased out to farmers who could not afford to own the land, a very common practice.



I asked the McWilliams about the property and they verified that the Beers family owned the property in the 1940's. There was a George H. Beers in the 1940 census living in Fair Oaks, listed as a Mine Superintendent. Evidently George died and his wife occupied the place with their daughter. The other owner known by our Facebook readers was the Bartlett family in the 1970s.

(On 1.45 acres, the house recently sold for \$875,000.)
