



WOMAN'S THURSDAY CLUB OF FAIR OAKS

Our History

During the month of November 2025, FOHS and The Woman's Thursday Club of Fair Oaks collaborated in the telling of the 120-year-long story of the history of The Woman's Thursday Club. The WTC display included a vintage mannequin displaying the message of "Equal Suffrage." Here are some highlights of that history.

1900s The Woman's Thursday Club was organized in 1902. Dues were \$1.10 with 10 cents for the State Federation of Women's Clubs. In 1905, the Club supported the Women's Improvement for Legislative Action on protecting land from dredgers.

1910s The Club built its first clubhouse. In 1911, the Club contributed to the University Loan Fund for Girls. In 1912, the Club endorsed a resolution to provide free textbooks for children in public schools. The Spanish Flu forced the Club to suspend meetings in 1918.

<u>1930s</u> The Club was active in aiding Native Americans through donations to the Indian Welfare Fund and in aiding needy veterans of the First World War. Scholarships were provided to students at San Juan Union High School. Musicals, book reviews and luncheons were Club activities during the years of the Great Depression.

The Club's membership increased after the Second World War. In 1953, a "pioneer tea" was held to celebrate the Club's 50th anniversary with 31 Fair Oaks "pioneers" attending. The first clubhouse was sold in 1954. The first meeting in the second clubhouse was held on March 10, 1955. Donations were made to "Save the Giant Redwoods," De Witt State Hospital (Auburn) and endorsements were made to insure adequate planning at Folsom Dam.

The Sixties were known for Club coffees, brunches, luncheons, teas, bridge tournaments and fashion shows. Bridge, Craft, Art, Garden, and Book Sections were active. Donations were made to the American Field Services student exchange program, to De Witt State Hospital and the USO. The Club was active in Women's Federation District and State meetings.

1970s Membership decreased during this decade. Scholarships became the Club's main philanthropy though donations were made to the Children's Receiving Home and the Psychiatric Ward at American River Hospital. The Club endorsed the Equal Rights Amendment. During the US Bicentennial Year, the Club published *Fair Oaks, The Way It Was, 1895-1976*.



FROM THE ARCHIVES

This is the third and final part of a three-part series on the Works Progress Administration projects in Fair Oaks. This article is on the 1940 remodel of the newly built Clubhouse.

In the last article that was in the Fall newsletter, the construction had been started on the new clubhouse. In May of 1936, Fair Oaks residents voted to give approval to help pay for the work, knowing that there would be a need for funds to cover all the costs. In August, 1936, a party was sponsored by the Community Club to raise funds to help with the construction of the new clubhouse and to lessen the burden on the Fair Oaks taxpayers.

The event was held at the Fair Oaks Elementary School site at the corner of Fair Oaks Blvd. and Winding Way on the tennis courts that were done earlier by the WPA. There were card games like whist and bridge where a person could win prizes. George Woodward, president of the Community Club, oversaw the arrangements.

In May, 1937, Slim Green, clerk of the Fair Oaks school board, called a meeting in the new clubhouse for the purpose of discussing the possibility of holding a dance there the last of May. The affair would be in the nature of a housewarming and proceeds would go to pay off some outstanding construction costs and to start equipping the building.

Two years later in 1939, Dr. Eugene. H. Buffum, Eric. E. Fulton, Richard. D. Borne, Bill Gregory, Justice of the Peace Toll G. Narramore and John E. Holst had an interest in the development of a recreational center in the vicinity of the Fair Oaks Community Clubhouse. They spent a good deal of time inquiring into the ways and means of utilizing much of the publicly owned acreage around

> the clubhouse which was serving no useful purpose.

They considered

two methods that could be used to get the work done. One would be to do a purely county-directed project or the other would be through the establishment of a local WPA project, which would have to be presented through the same channels as the earlier work of tearing down the old school and building the clubhouse.

At their August meeting of that same year, there was talk of the need for a public swimming pool and for the completion of the interior of the clubhouse. Also, some effort should be made toward developing a better location for the weekly band concerts which were drawing increasingly larger audiences every Wednesday evening at Fair Oaks plaza.

By the third week of October, 1939, the plans for the development of the area around the Fair Oaks clubhouse to provide a bandstand, a swimming pool and a softball diamond had been sketched for presentation to proper authorities to securing WPA (now called Work Projects Administration). Active in the preliminary work, were Judge Narramore, Borne, Norman Langness, Dr. Buffum, and others.

In November, Borne and Judge Narramore appeared at the Men's Brotherhood of the Fair Oaks Federated Church meeting and outlined the plans for developing the grounds adjacent to the clubhouse, which would

include a bandstand, a swimming pool and a softball diamond; most of the labor would be supplied by the WPA. The brotherhood indicated their approval.

On January 25, 1940, the project had already received assurances of donations of adequate materials from local residents and businesspeople to take care of the rest. With the aid of a \$300 appropriation by the Fair Oaks school district and a \$16,000 project for civic improvement, they would be under way.

Still needing \$450 to start a WPA project, a group of Fair Oaks businessmen met in the court of Justice Narramore and quickly underwrote that amount. Within half an hour after the group had decided to underwrite the project, the following names had been secured: Ralph Hinsey, William Codd, Leon N. Wheaton, Dewey Rice, Chester E. Hinshaw, S. E. Green, William Gregory, E. E. Fulton, R. D. Borne, Clerence A. Champlin, Robert. F. Broadley, T. G. Narramore, John E. Holst, Nat R. Smith, Dr. Norton A. Archer, Geo. W. Conkey, Carl F. Stark, Clayton E. Vaughan, Bert R. Hild and Norman Langness and maybe others were added later.


March, 1940, the official okay for the project to reroof and finish the inside of the Fair Oaks Community Clubhouse, grade and level adjacent ground to provide a softball field and parking space and to construct a bandstand had been received from WPA headquarters according to Justice Narramore. WPA was anxious to get started in order to complete it before the end of the fiscal year.

Holst was named project superintendent. On Monday morning of April 29^{th,} the work on the WPA project got under way. A general cleanup of the grounds was undertaken with another crew of men preparing the roof of the building for recovering.

Judge Narramore called a meeting of all people interested in the project for Monday afternoon at 5 o'clock at his office to discuss proposals for important changes in the landscaping work. The group visited the site to consider the proposals. They selected the color for the building exterior which was cream with red trim and ceiling inside was to be finished in aluminum paint to provide better lighting.

The hill approaching the building from the south would be excavated to provide parking space and the dirt would be moved to the side where it would be used to fill in low spots for the softball field. The present project did not include the construction of a swimming pool; that matter was being placed on file for future condition.

In one week the WPA crews were making rapid headway in reroofing the Fair Oaks Clubhouse, completing the interior finish of the building and excavating for parking lots and the bandstand outside.

Following the completion of the WPA part of the of project on August 13th, with the bandstand now ready for use, how to further

reported that the school board spent \$1,250 on the completed project. Local material and equipment contributions brought the community's cooperative effort up to \$2,150. The WPA expense was \$7,750.

Now 85 years later, Fair Oaks Recreation & Park is finishing up the latest remodel of the Community Clubhouse, Plaza Park and Amphitheater. The old building, that Toll Narramore owned where the meeting was held in his office in 1939, had to be removed for the amphitheater remodel. One of the last businesses that was in the building before it was torn down was a beauty salon.

improve the Fair Oaks Clubhouse site was discussed at a meeting held in the clubhouse on Tuesday, August 20, by R. D. Borne secretary/treasurer of the unofficial group of Fair Oaks businessmen and civicminded citizens who sponsored the job. During the meeting Holst, Gregory and Narramore were named to sand the floor and get it ready for use. Dr. Buffum was appointed to inquire into the possibility of a new lawn covering. Holst, Nat Smith, Lorrin Booth and Lou Gerhardt were named to determine the building's requirements in electrical installation. Eric Fulton, F.U. Orr and Bud

Fulton were named to see about getting pipe for guard rails and placing them. John E. Holst
